



8. The note is itself evidence of the existence of the debt and its introduction into evidence is sufficient to establish a *prima facie* case. When it is regularly admitted into evidence, no additional evidence of the present existence of the debt is necessary upon the case of Plaintiff. Knauser v. Levy, 115 So. 2d 776, 777 (Fla. 3<sup>rd</sup> DCA 1959).
9. The record reflects that there are no genuine issues of material fact and that the Plaintiff is entitled to foreclose the mortgage as a matter of law.

#### REESTABLISHMENT OF PROMISSORY NOTE

10. Plaintiff moves the Court for entry of a final judgment reestablishing the note with all the rights and privileges incident to it as prayed for in the Complaint filed herein on the grounds that there are no issues of material fact and that Plaintiff is entitled to such relief as a matter of law. The allegations of the Complaint are sufficient to reestablish the lost instrument and have not been controverted.

#### REFORMATION OF MORTGAGE

11. Plaintiff further moves the Court for entry of a final judgment reforming the mortgage on the grounds that there is no dispute as to a material fact and as matter of law the mortgage should be reformed to correctly describe the property as prayed for in the Complaint filed herein. The allegations of the Complaint are sufficient to reform the mortgage and have not been controverted.

WHEREFORE, Plaintiff respectfully requests that this Court enter a Final Judgment of Mortgage Foreclosure, award attorney's fees and costs, and grant such other relief as may be just and proper.
