

SAMPLE MORTGAGE MODIFICATION AGREEMENT

A mortgage from John L. Jones to the X Y Z Bank and Trust Company dated January 00, 000 and recorded in Volume 000, Page 000 of the \_\_\_\_\_ Land Records, which was assigned to the Connecticut Housing Finance Authority by instrument dated January 00, 0000 and recorded in Volume 000, Page 000 of the \_\_\_\_\_ Land Records, is corrected as follows:

- 1) By changing the interest rate from 0% to 0%;
- 2) By changing the principal amount of the note secured by the mortgage from \$00,000 to \$00,000.00;
- 3) In the blank space on line X of the Mortgage Deed, the principal debt of \$00,000 is inserted;
- 4) In the blank space on line X, an interest rate of 0% per annum is inserted;
- 5) By changing the monthly installment payment from \$000.00 to \$000.00;
- 6) The maturity date of the mortgage debt is changed from February 00, 0000 to January 00,000.

All the remaining provisions of said Mortgage Deed, not specifically changed or modified herein, are to remain in full force and effect.
