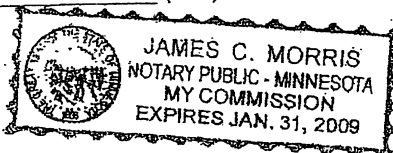

Fidelity-LPS is not a MERS member so there would have to be tri-party authorization for them to sign anything for MERS.
