- 1. Several questions dealing with when to allow the submission of documents with a copied signature.
- 2. Several patentable subject matter questions covered by 35 U.S.C. 101.
- 3. 4 questions related to KSR and Bilski, all of which have been posted on the Exam Question Post.
- 4. Obviousness questions dealing with the rules, rejection and when you can use 1.131.
- 5. Quite a few Reissue questions dealing with the various aspects of whether you can or cannot broaden a Reissue or if an assignee can file one, can an assignee file.
- 6. Questions dealing with getting around statutory and nonstatutory double patenting.
- 7. Quite a few questions on 35 U.S.C. 112 dealing with enablement, written description, is there support in the specification, etc.
- 8. Many questions on Appeal, which covered when you can file what, the effect of an RCE, what your options are before and after each of the milestones, and what happens to the various types of claims upon the withdrawal or abandonment of the application.
